Amarillo Escape and Mystery and NeeseyWinks, LLC operates and/or conducts escape room and mystery events. Participating in an event could result in injuries to the participant. The participant, by executing his or her signature to this release, does release, waive and discharge not to sue Amarillo Escape and Mystery and/or NeeseyWinks LLC, its officers, members, promoters, owners, employees, contractors or business partners for any and all liability, injuries, and/or any and all other claims and damages as a result of participating in an event sponsored by Amarillo Escape and Mystery and/or NeeseyWinks, LLC.

In addition, the participant releases any and all claims, damages, injuries, and all else that incurs by participating in such events. The participant agrees to release any and all claims of whatever kind of nature, present and future, damages and injuries. The participant assumes full responsibility for and risks bodily injury, paralysis, death, or property damage due to negligence or non-negligence of Amarillo Escape and Mystery, NeeseyWinks, LLC, its owners, employees or contractors conducting events.

The participant further acknowledges he or she is voluntarily participating despite the risks including but not limited to falls, flying objects, defective equipment, contact with other participants and the condition of the facility.
